**Liability Release.** For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, \_\_\_\_\_, as self/parent/legal guardian of \_\_\_\_\_ (referred to as Minor), hereby grant the permission necessary to allow Minor to participate in the Event above to be conducted by El Paso County Coliseum, El Paso Sun Dance Showcase and Monica Perez-Nava. I, in my own behalf and on behalf of the Minor, further agree to release and to hold harmless El Paso Sun Dance Showcase, El Paso County Coliseum, Monica Perez-Nava, and/or any of its associates, sponsors, volunteers, etc. from any and all liability whether caused by negligence of the Releasees or otherwise for any claim judgment, loss, liability, cost and expenses (including, without limitations, attorney's fees and cost, arising out of or connected with the Event, including any claim arising out of or connected with any illness or injury (minimal, serious, catastrophic and / or death) that the Minor or self may incur or sustain during the Event, all activities associated with the Event and while traveling to and from the site for the Event whether or not the Event actually occurs. I further expressly agree to indemnify and hold harmless Releasees and Releasees' heirs, successors, assigns, executors and administrators against loss from any further claims, demands or actions that may subsequently be brought by Minor or by any other persons on the account of damages of any character resulting to Minor in any way from the foregoing activities. I further agree to reimburse and to make good to releasees any loss or costs Releasees may be to pay as a result of any such action claim, or demand.

**Medical Release.** I, in my own behalf and on behalf of the minor, acknowledge and agree that such participation, subjects Minor to possibility of physical illness or injury (minimal, serious, catastrophic and/or death) and that I, in my own behalf and on behalf of the Minor, acknowledge that the Minor is assuming the risk of such illness or injury by participating in the Event. In the event of such illness or injury, I authorize El Paso County Coliseum, El Paso Sun Dance Showcase to obtain necessary medical treatment of the minor and hereby, in my own behalf and on behalf of the Minor, release and hold harmless Releasees in the exercises of their Authority. I further acknowledge and understand that I will be responsible for any and all medical and related bills that may be incurred on behalf of the Minor for any illness or injury that the Minor may sustained during the Event and while traveling to and from the site for the Event whether or not the Event actually occurs.

**Appearance Agreement.** I understand that El Paso Sun Dance Showcase will be photographing and recording the Event. I understand that as a participant and /or spectator at the Event that Minor may be included in videotapes, photographs, DVDs, podcasts and video casts taken during the Event. Therefore, without reservation or limitations, I, in my own behalf and on behalf of the Minor, hereby assign, transfer and grant to El Paso County Coliseum, El Paso Sun Dance Showcase, its successors, assignees, licensees, sponsors, promoters, any television networks, and all other commercial exhibitors the exclusive right to photograph and/ or videotape the Minor and to utilize such videotapes and photographs and Minor's name, face, likeness, voice and appearance as a part of the Event, in advertising and promoting the Event or in advertising and promoting similar future events. I further understand that neither El Paso County Coliseum, El Paso Sun Dance Showcase nor any third party is under any obligation to exercise any of the foregoing rights, licenses and privileges. I, in my own behalf and on behalf of the Minor, waive any right to inspect or approve the copies of any promotional materials related thereto.

**Event Rules and Regulations;** I further acknowledge and understand that El Paso County Coliseum and El Paso Sun Dance Showcase has established rules and regulations pertaining to conduct, behavior and activities of Event Participants, by which Minor and I agree to abide during the Event (copy of which is included with this release and waiver form), and that Minor and I will be responsible for his/her/my failure to abide by those rules and regulations. Minor and I have received, read and understand the Event rules. Minor and I understand that violation of the rules can result in dismissal and disqualification from Event with no refund.

I, in my own behalf and on behalf of the Minor, hereby warrant that I have read this Liability Release in its entirety and fully understand its contents.

I, in my own behalf and on behalf of the Minor, am aware that this Liability Release releases Releasees from liability and contains an acknowledgement of my voluntary and knowing assumption of the risk of injury or illness.

I, in my own behalf and on behalf of the Minor, further acknowledge that nothing in this Liability Release constitutes a guarantee that the Event will occur.
